

# SCHOOL ENROLMENT AGREEMENT

### THIS ENROLMENT AGREEMENT OUTLINES THE RESPONSIBILITIES OF THE STUDENT, PARENTS & CARERS AND SCHOOL STAFF, REGARDING THE EDUCATION OF STUDENTS ENROLLED AT CAPELLA STATE SCHOOL.

#### Our school values Be a Learner, Be Respectful, Be Responsible Be Safe.

These core values are embedded in our curriculum and social education programs.

#### STUDENTS ARE RESPONSIBLE FOR:

- attending school regularly, on time, ready to learn and take part in school activities
- acting at all times with respect and displaying tolerance towards other students and staff
- working hard and complying with requests or directions from the teacher and principal
- abiding by school rules, meeting homework requirements and wearing the school uniform
- respecting the school environment.

#### PARENTS ARE RESPONSIBLE FOR:

- attending open evenings for parents
- letting the school know if there are any problems that may affect their child's ability to learn
- informing the school of reason for any absence
- treating school staff with respect and tolerance
- supporting the authority and discipline of the school enabling children to achieve maturity, self discipline and self control
- abiding by the school's policy regarding access to school grounds before, during and after school hours.

#### THE SCHOOL IS RESPONSIBLE FOR:

- developing each individual student's talent as fully as possible
- informing parents and carers regularly about how their children are progressing
- informing students, parents and carers about what the teachers aim to teach the students each term
- teaching effectively and to set the highest standards in work and behaviour
- taking reasonable steps to ensure the safety, happiness and self-confidence of all students
- being open and welcoming at all reasonable times and offering opportunities for parents and carers to become involved in the school community
- clearly articulating the school's expectations regarding the responsible behaviour plan for students and the school's dress code policy
- ensuring that the parent is aware of the school's record-keeping policy including the creation of a transfer note should the student enrol at another school
- setting, marking and monitoring homework regularly in keeping with the school's homework policy
- contacting parents and carers as soon as is possible if the school is concerned about the child's school work, behaviour, attendance or punctuality
- dealing with complaints in an open, fair and clear manner
- consulting parents on any major issues affecting students
- treating students and parents with respect and tolerance.
